- [\*Pilon c. Banque Amex du Canada\*](#) regarding over-the-limit spending on credit cards, in which the Court also dismissed an application at the authorization stage, a decision later confirmed on appeal and maintained up to the Supreme Court dismissal of the petition for judicial review;
- [\*Haroch c. Toronto-Dominion Bank\*](#), challenging the mortgage prepayment charges levied by The Bank of Nova Scotia and other banks, and dismissed for the second time at the authorization stage.

Methodical and efficient, Karine is often asked to manage cross-jurisdictional files involving stakeholders in other parts of Canada, but also in the U.S. and elsewhere in the world.
